EDUCATION AND CARE SERVICES NATIONAL LAW AND NATIONAL REGULATIONS

Education and Care Services National Law Act 2010: Section 167 Protection of children from harm and hazards

'A family day care educator must ensure that every reasonable precaution is taken to protect a child being educated and cared for as part of a family day care service from harm and from any hazard likely to cause injury.'

Penalty: \$10,000

Educators must be able to provide evidence to the authorised officer that they are aware of any potential or ongoing maintenance and safety issues that may present an undue risk to children. They must balance the obligation to protect children from harm against the benefit of providing children with a stimulating play environment.

The items on an educator's checklist should reflect circumstances relevant to the registered premises, the ages of the children in care, their developmental needs and the way in which they are supervised. The educator's daily practices should demonstrate an awareness that children's safety is an ongoing responsibility. Daily safety checks of the environment and equipment are an essential way of showing that reasonable precautions are being taken to ensure the safety of all children in care.

Educators are to inspect both the indoor and outdoor areas of their homes each day that children are in care. Any hazards are to be removed prior to children commencing care. If the hazard is unable to be rectified immediately, then a risk management plan must be put in place to protect children.

Educators are to initial each day that children are in care, or when prospective families visit outside care hours, to verify that a daily safety check has been carried out and that the environment is safe. Coordination staff are to sign and date the form when visiting an educator as confirmation that the educator is complying with the National Law and Regulations.

Note: Family day care educators must notify the scheme of any changes that may affect the provision of care, eg. acquiring a pet, proposed renovations, or the name and accompanying WWCC of any person over the age of 18 intending to live at the family day care residence.
